The remaining balance should be made out to "Chris Padgett" and is to be paid to Chris at the event.

TRAVEL: Travel for Chris will be paid for by the Sponsor, and the itinerary may be booked by our travel agent, Patty, at 941-798-2221 (x2229), or arranged by the Sponsor and emailed to Chris in a timely manner. Also, please arrange transportation for Chris from the airport to the venue.

LODGING AND MEALS: Please provide lodging and meals for Chris throughout the duration of his stay. It is best if the Sponsor checks Chris in ahead of time and hands off the hotel key to him upon his arrival.

SOUND AND LIGHTS: Please provide adequate sound in relation to the amount of people and size of room you have for the event. In places where amplification is required, Chris will need a hand held microphone and a 1/4 inch cable, and input to plug his guitar into. It is necessary that the area where Chris will be speaking or performing is sufficiently lit, and it is preferable that the group he is ministering to can be dimly lit (or dark). If you have any questions, please call Chris.

MERCHANDISE: Please provide a table and at least one volunteer to sell merchandise during the event. The sponsor and the sponsoring organization agree to let Chris sell merchandise royalty free. The Sponsor can also order Chris's product on consignment to sell and make a profit. The CD's Golden and Impact can be ordered from OCP (800-LITURGY) and the book, "Not Ready For Marriage, Not Ready For Sex," can be ordered from Servant Publications, (800-488-0488) by contacting Chris Holmes.

SOUND CHECK: Under normal circumstances, Chris will need a fifteen (15) minute sound check with the audio engineer some time before the performance. It is helpful to have the room cleared of participants at this time.

CANCELLATION: The ability for Chris to continue to minister depends upon your commitment to the performance scheduled. Because of the expenses incurred in preparing for this appearance, the deposit paid upon execution of this agreement is non-refundable. In the event of cancellation within ninety (90) days of the scheduled date, the Sponsor is responsible for the honorarium and any travel expenses incurred at the time of cancellation. Full payment of the honorarium (less deposit) is and any travel expenses incurred is required immediately upon cancellation.

This agreement is entered into in the spirit of Christianity and for the purpose of establishing good communication and mutual understanding regarding the personal appearance of Chris Padgett. The Sponsor's signature below acknowledges that she/he is in agreement with the provisions of the letter.
